

Parcel Tax History

- 1995-2005: Library Benefit Assessment District
- November 2004 Measure S approved
 - Parcel Tax: Sunset in 2015
- June 2014 Measure B approved
 - Parcel Tax, subject to inflation
 - \$25 per year per single family home
 - Proportional assessment for other property types
 - Effective July 2015 2040

Bond History & Scope

- November 2000: Measure O approved
 - \$211,790,000 general obligation bond
- Restricted for the purchase of property and construction of improvements to libraries
 - No administration/staffing
 - New in 2019-2020, capital project management staff charges no longer allowed by the City. In prior years, capital project management staff could be charged to Bond Funds.
